2. Select a proposed additional Park facility (for the northeast end): (a) Community Stage, (b) Dog Park, (c) Event Lawn, (d) other, or (e) none;
3. Whether or not to proceed with bond financing and if yes, direct staff to assemble a Bond Financing Team
