- 1. Award a contract to Rincon Consultants, Inc. to provide professional services to prepare a Climate Action Plan, not to exceed an amount of \$118,915 without City Council authorization;
- 2. Approve said Agreement for two (2) years beginning August 8, 2018 and expiring on August 7, 2020;
- 3. Reject all other proposals;
- 4. Authorize the City Manager to execute and administer said Agreement in substantially the form attached, and in such final form as approved by the City Attorney;
- 5. Utilize \$40,000 from Measure R Fund (16-5500-6216) as prescribed in the 2018-2019 Annual Budget; and
- 6. Appropriate \$78,915 from Capital Equipment Fund (25-5001-6216), contingent upon the surplus of unexpended funds at the close of the 2017-2018 fiscal year, to be carried forward into the 2018-2019 fiscal year, pending City Council approval at the August 22, 2018 meeting.

# 9. Award of Bid to E.C. Construction and Appropriation of \$216,804 to Construct the Walnut Veterans Memorial

**Recommendation:** That the City Council:

- 1. Award a construction contract for the Walnut Veterans Memorial to E.C. Construction Company for \$183,600;
- 2. Authorize the City Manager to sign the contract on behalf of the City and in such form as approved by the City Attorney (on file in the City Clerk's office);
- 3. Appropriate \$216,804 from General Fund Reserves to the Project (\$7,500 to 01-6109-6216 and \$209,304 to 01-6109-6227);
- 4. Authorize staff to issue a Purchase Order to E.C. Construction Company in the amount of \$183,600;
- 5. Authorize staff to issue a Purchase Order to RKA Consulting Group in the amount of \$7,500; and
- 6. Authorize staff to expend contingency funds for change orders to E.C. Construction Company and/or authorize the City Manager to contract for construction work as required to illuminate the flags in an amount not to exceed 14% of the construction contract or \$25,704.
