5. Award of Contract to the Law Office of Charisse L. Smith for Walnut Code Enforcement Legal Services

Recommendation: That the City Council:

- 1. Award a contract to the Law Offices of Charisse L. Smith for Code Enforcement legal services, in an amount not to exceed \$35,000.00;
- 2. Approve Professional Services Agreement for sixteen (16) month term beginning February 14, 2019 and expiring on June 30, 2020;
- 3. Authorize the City Manager to execute and administer said Agreement in substantially the form attached, and in such final form as approved by the City Attorney;
- 4. Appropriate \$35,000.00 from the General Fund Reserves to 01-5002-6216; and
- 5. Issue a Purchase Order to the Law Offices of Charisse L. Smith in an amount not to exceed \$35,000.00.

M/Tragarz expressed concerns regarding certain aspects of the contract and stated that if consultant compensation should change, that it be taken back to Council for approval.

CA/Leibold stated that any change in compensation that is over the City Manager's approval authority, would be taken to Council; she stated that they will clarify that in the contract.

M/Tragarz stated that she feels that every contract should be approved by the city attorney and city manager and then signed by the mayor.

CA/Leibold stated that Council may change the recommendation to have the mayor sign and execute the contract.

M/Tragarz moved to strike through the second sentence in section 4 of the contract and approve all of staff's recommendations for Item 5 except recommendation number three; seconded by C/Ching. Motion carried by the following electronic vote:

6. Award of Bid – FY 2018-19 Area 4 Pavement Resurfacing Project

- 3. Appropriate \$49,000.00 from the 03- Road Maintenance Rehabilitation Account (RMRA) Reserves and \$165,500.00 from the 13- Proposition C Reserves to the project;
- 4. Authorize staff to issue a Purchase Order to Hardy and Harper, Inc. in the amount of \$695,000.00;
- 5. Authorize staff to issue change orders not to exceed \$69,500.00 (10% of the contract award amount) to Hardy and Harper, Inc.; and
- 6. Authorize staff to issue a Purchase Order to RKA Consulting Group in the amount of \$50,000.00

7. Award of Bid – FY 2018-19 Maintenance Area 4 Slurry Seal Project

Recommendation: That the City Council:

- 1. Award a construction contract for the 2018-19 Maintenance Area 4 Slurry Seal Project to Doug Martin Contracting Company, Inc. in the amount of \$659,113.50;
- 2. Reject all other bids;
- 3. Appropriate \$115,024.85 from 03- Road Maintenance Rehabilitation Account Reserves to the project;
- 4. Authorize staff to issue a Purchase Order to Doug Martin Contracting Company, Inc. in the amount of \$659,113.50;
- 5. Authorize staff to issue change orders not to exceed \$65,911.35 (10% of the contract award amount) to Doug Martin Contracting Company, Inc.; and
- 6. Authorize staff to issue a Purchase Order to RKA Consulting Group in the amount of \$65,000.00.
