Quarterly (mid-year) Budget Review

- Revenue Opportunities

ASD/Ogawa provided a detailed summary of the second quarter of the 2018-19 Budget and discussed the following: general fund revenues and expenditures, budget amendments and the projects associated, and additional expenditures.

ACM/Rooney shared financial information regarding the LED street light conversion rebate, grant funding from Foothill Transit for bus stops, and savings from the irrigation controller project.

ACM/Weiner provided information regarding development agreement fees from current and future projects in the city as well as a profit sharing agreement with Shea Homes.

Discussion took place amongst Council and staff regarding the following: expenditures and revenues, lighting and open space management district (LOSMD) landscaping costs and the loans associated, special revenues and restricted funds, net positions over the last ten years, and the facility maintenance fund.

CM/Wishner shared information regarding additional revenues projected as well as other options to increase revenue.

Discussion took place amongst Council and staff regarding the following: a donation from City Blessing Church to be used towards to camera program, commercial opportunities

from the 49 acre site, the possibility of a hotel and revenues associated, and future commercial possibilities throughout the city.
