5. 2016-17 Mid-Year Request for Additional Appropriation

Recommendation: That the City Council increase revenue projections in the amount of \$7,970 and appropriate funds in the amount of \$7,970 from the General Recycling Grant Fund; and appropriate funds from LOSMD Fund Reserves in the amount of \$30,000 to the following accounts:

- 1. General Recycling Grant, Revenue Account No. 33-0000-3878, in the amount of \$7,970, to account for the grant funds received to establish and promote recycling and litter reduction efforts in the community.
- 2. General Recycling Grant, Expenditure Account No. 33-5605-8410, in the amount of \$7,970, to provide recycling bins in City parks, facilities, and at local schools.
- 3. LOSMD Fund, Zone 8, Expenditure Account No. 19-7800-6243, in the amount of \$30,000, for the removal of hazardous tress within LOSMD Zone 8, and upon removal re-landscape areas with new trees, shrubs, and ground cover as deemed appropriate.

6. Request for Appropriation of \$23,929.64 from the General Fund to Account 01-5314-6227 to be reimbursed by Foothill Transit for Bus Stop Enhancements

Recommendation: That the City Council:

- 1. Approve the Bus Stop Enhancement Program Agreement with Foothill Transit in substantially the form attached and authorize the City Manager to execute the Agreement in such final form approved by the City Attorney;
- 2. Authorize the City Manager to execute all necessary payment requests and amendments for the purposes of securing Foothill Transit Bus Stop Enhancement Program grant funding; and
- 3. Appropriate \$23,929.64 from the General Fund to Account 01-5314-6227 to be reimbursed by Foothill Transit for Bus Stop Enhancements.
