Recommendation: That the City Council:

- 1. Award bid to Gentry Brothers, Inc. (Gentry Brothers) and approve a construction contract for the La Puente Road Rehabilitation Project to Gentry Brothers in the amount of \$507,672.50;
- 2. Reject the bid of All American Asphalt as incomplete and unresponsive;
- 3. Reject the bid protest submitted by Excel Paving Company regarding the formal bid submitted by Gentry Brothers;
- 4. Reject all other bids;
- 5. Appropriate \$270,000 from Measure R Reserves (Fund 16) to the Project in place of the FY 18-19 budgeted amount of \$270,000 from Measure M (Fund 21):
- 6. Appropriate \$90,900 from Proposition A Reserves (Fund 23) to the Project;
- 7. Appropriate \$167,540 from Proposition C Reserves (Fund 13) to the Project;
- 8. Authorize staff to issue a Purchase Order to Gentry Brothers in the amount of \$507,672.50
- 9. Authorize staff to issue change orders not to exceed 10% of the contract award amount (\$50,767) to Gentry Brothers; and
- 10. Authorize staff to issue a Purchase Order to RKA Consulting Group in the amount of \$50,000.

Recommendation: That the City Council:

- 1. Approve the bingo permit application submitted by the Walnut Senior Citizens Club for Fiscal Year 2019-20:

- 3. Waive the bingo permit application fee and monthly gross receipts fees; and

- 2. Authorize the Assistant City Manager Community Services/Public Works to execute and administer said agreements in substantially the form attached and in such final form as approved by the City Attorney; and
- 3. Approve the following Sunday Use and Tournament requests.

Field Use Requests:

a) Use of **Butterfield Park** by DBWV-FC Man United Soccer from August 1, 2019 through December 1, 2019; and AYSO from December 7, 2019 through January 31, 2020.

- b) Use of **Creekside Park** by Walnut Valley Pony Baseball from September 2, 2019 through November 23, 2019 for practices/games;
- c) Use of **Snow Creek Park** by Walnut Valley Pony Baseball from September 2, 2019 through November 23, 2019; and Walnut Valley Cowboys (Football and Cheer) from July 22, 2019 through December 31, 2019.
- d) Use of **Suzanne Park** by Walnut Youth Softball from August 1, 2019 through November 30, 2019 for practices *(excluding October 11-12)*; and DBWV-FC Man United Soccer from August 1, 2019 through December 1, 2019 *(excluding October 11)*;
- e) Use of **Walnut Ranch Park** by AYSO from August 1, 2019 through December 7, 2019 (excluding October 11 due to Westhoff Elementary School event); and DBWV-FC Man United from August 1, 2019 through December 1, 2019 (excluding October 11 due to Westhoff Elementary School event). There is mutually agreed upon division of field use between AYSO and DBWV-FC Man United Soccer;
- f) That the request for Sunday use of **Walnut Ranch Park** be approved as in previous years for DBWV-FC Man United Soccer; and
- g) That the tournaments be approved as requested.

Sunday Use and Tournaments Requests:

Waivers for Sunday use have been approved following consideration by the Parks and Recreation Commission and the City Council, and again, are being requested by DBWV-FC Man United at Walnut Ranch Park.

The Facility Use and Allocation Policy states that "Sports organizations with approved Facility Use Permits are limited to two tournaments per year." The following youth sports groups have requested tournaments at the following parks:

AYSO: August 5, 6, 7, 8 and 9

DBWV-FC Man United Soccer: August 2, 3 and 4; August 9, 10 and 11; and November 29, 30 and December 1
