Carmen Robles expressed concerns regarding speeding on Camino De Teodoro and requested speed bumps be installed.

3. The Terraces at Walnut Development (49 Acres): A proposal to subdivide a 49-acre property for the purposes of developing residential units, a commercial center, pocket parks, and open space (APN: 8709-023-006/007/008

Mayor Rodriguez opened the public hearing.

ACM/Weiner presented a staff report.

John Danvers, Shea Homes representative, presented information regarding the project. He stated that they have made adjustments to accommodate the Planning Commissions concerns regarding parking and park size.

Suzanne Huerta, Rincon Consultants representative, provided information regarding the environmental impact report (EIR) and California Environmental Quality Act (CEQA) requirements.

C/Tragarz arrived to the meeting during the discussion at 7:38 p.m.

Discussion took place regarding the final EIR and the Planning Commission recommendations of the project.

Mayor Rodriguez opened public comment.

Gordon Nichols, Hassan Sassi, Jerry Lee, Ricky Chen, William Harrison, and Fernando Perez expressed support for the project.

William Harrison asked that Council address issues with the Creekside neighborhood.

Paul Yen and Brenda Whitney expressed concerns regarding issues created by increased housing in Walnut.

Discussion took place regarding the following: mitigation efforts, traffic concerns, potential property tax and sales tax revenues, and state housing requirements.

C/Wu stated that he was not in favor of the following: increasing park size or retail space, a pedestrian walkway from the neighborhood to the retail space, and the extension of pedestrian access on Roundup Drive. He suggested mitigation for transportation and traffic issues.

C/Tragarz stated that she was in favor of increasing commercial size in the development as well the pedestrian access to Roundup Drive, and the increased size of "Park F."

C/Rodriguez asked that the pedestrian access to Roundup Drive extend to the public right of way rather than the lot line, to which John Danvers agreed. Staff stated that they would add the condition.

There being no further input, it was moved by M/Rodriguez to close the public hearing; seconded by MPT/Pacheco. Motion carried.

9. Coyotes – Citywide Management Options

- 2. Appropriate \$10,000 from the General Fund Reserves to facilitate and implement the identified practices in response to coyote encounters.

SMA/Guerra presented a staff report.

Discussion took place regarding the following: the recommended appropriation, coyote management plan, coyote deterrents and staff protocol for coyote complaints.

M/Rodriguez opened public comment.

Norman Owashi, Isabelle Owashi, Paul Chen, Laurie Jimenez, Jim Lolly, and Resident expressed concerns regarding coyote prevalence in residential neighborhoods.

Resident stated that he feels the coyote issue is a statewide issue and that the California Department of Fish and Wildlife needs to provide more resources.

Resident thanked Council and staff for their efforts to address the coyote matter.

Jerry Bastille expressed concerns regarding an animal that he feels is larger than a coyote that has been present near his residence.

There being no further input, it was moved by MPT/Pacheco to close public comment; seconded by M/Rodriguez. Motion carried.

C/Ching asked staff to bring the item back if the coyote issue remains prevalent.

C/Tragarz stated that she is in favor of having staff monitor the issue and bring the item back if there is a need.
