Layla Abou-Taleb expressed concerns regarding the parking facilities portion of the ordinance and requested that parking structures be under city jurisdiction.

Gary Gecum expressed support for the zoning ordinance.

Discussion took place regarding the ordinance including: setback distances for parking lots and parking structures, the effects and future protocols of the ordinance, and definitions within the code.

It was the consensus of Council to amend the ordinance to reflect the following: parking lots would be a permitted use and require 300ft setbacks and parking structures, defined as two levels of parking or more, would be a conditionally permitted use requiring a conditional use permit and would require 400ft setbacks.

There being no further input, it was moved by M/Rodriguez to close the public hearing; seconded by MPT/Pacheco. Motion carried.
