PC/Perez moved to approve the minutes of the regularly scheduled January 15, 2020 PC minutes. VC/Koo seconded. Motion passed 4-0.

PUBLIC HEARING(S):

2. <u>Continuance – Brookside Equestrian Center (Brookside):</u> A proposal to subdivide a 25.8-acre property into twenty-eight (28) single-family residential lots and other on-site improvements at 800 Meadowpass Road.

SP/Vasquez presented the Staff Report.

The PC and Staff discussed proposed alterations to the site design/layout, preservation of the main stable, and other on-site improvements.

VC/Koo opened the item for Public Comment(s).

Project Designer/Scott Ashlock briefly discussed the proposal of a dedicated open space lot and the preservation of the main stable.

The PC, Staff, and Applicant further discussed open space dedication, private road(s) and maintenance, and site/trail improvements.

The following sixteen (16) Residents declared opposition to the project – Jenny Ha, Donna Daigle, Deidre Vail, William Harrison, Vijay Vakil, Andrea Horn, Mark Johnson, Marilyn Ho-Kawate, Karla Cardenas, Cecil Brado, Elizabeth Quint, Diane Turner, Florencia Cardenas, Kim Ha, Hi-Ching Chia, and Becky King. Resident stated concerns included but were not limited to:

- Emergency access;
- Traffic congestion;
- Public outreach and notification;
- Conservation and preservation of the existing carriage house and associated barn/stables;
- Preservation of existing trees/vegetation;
- Dedication of open space/parks to the community;
- Environmental impacts (i.e. possible destruction of existing natural habitats);
- Deviation from the Walnut Zoning Code.

Resident(s)/Anabelle Pacheco and Jesse Rodriguez were in favor of the proposed development and the applicant's right to develop.

The PC and Mr. Ashlock further discussed the proposed Lots that are to be affected by the project revision, the structure(s) that would be preserved/rebuilt, potential community benefits from the project, and details regarding the trail(s).

Mr. Ashlock addressed some of the resident's concerns about emergency access. He further added that visual simulations of the project site are available within the Draft Environmental Impact Report (DEIR).

The PC, ACM/Weiner, and resident(s) Vijay Vakil, Kim Ha, and William Harrison further discussed concerns regarding consistency with the Walnut Zoning guidelines, ingress/egress from the development onto La Puente Road, the size of proposed new structure(s), and the amount of trails (in miles) proposed.

PC/Perez motioned to close the item for Public Comment(s). PC/Fernandez seconded.

PC/Fernandez and ACM/Weiner further discussed preservation of the existing stable/structure(s) and property maintenance.
