CE/Gilbertson stated that the purpose of the VMT analysis is to promote more mixed use developments to eliminate long commutes by decreasing VMT numbers and increasing work/home accessibility.

The PC and Staff briefly discussed changes, if any, to the Walnut Zoning Code.

Staff confirmed that submitted projects that are required to comply with CEQA guidelines, after the adoption of the VMT thresholds, must comply with mechanisms to mitigate VMT impacts.
