William Harrison expressed concerns regarding the current state of the shopping center and expressed support to move forward with the public nuisance.

Art Flores, partial owner of the Lemon Creek Village shopping center, stated that he would like to meet with someone to do a complete inspection of the center and also shared that they are not in control of the whole center.

Discussion took place regarding the history of code enforcement violations on the property and the issue of reoccurring violations, the public nuisance abatement process, and the opportunity for the property owner to comply with violations.

Art Flores stated that it is difficult to address issues with common areas because all owners need to be in agreeance.
