6. <u>Approval of Contract Extensions for Maintenance Services with Athletic Field Specialists, RPW Services and Nieves Landscaping with No Rate Increases</u>

- 1. Approve a three year contract extension with Athletic Field Specialists (AFS) for sports field maintenance services through June 30, 2024 with no rate increases;

- 3. Approve a one year contract extension with Nieves Landscaping for citywide landscape maintenance through June 30, 2022 with no rate increases; and
- 4. Authorize the City Manager to execute the Amendments on behalf of the City in substantially the form attached and in such final form as approved by the City Attorney.
