10. Appeal - Planning Commission Approval of Site Plan Case/Architectural Review (SPC/AR) 2021-003 (Nicholls)

Recommendation: That the City Council:

M/Pacheco stated that C/Wu asked to recuse himself from the discussion due to a conflict of interest as he owns property in close proximity to the subject property.

SP/Vasquez provided a staff report.

CC/De Dios stated that she received letters and a petition of support for the appellant's proposed plan.

Jennifer Nicholls, appellant, shared information on her proposed plan and asked Council to approve her plan.

Discussion took place amongst Council and staff regarding the following: options for the appeal, background information on the property, and potential design options for the property.

C/Freedman stated that submitting professional plans to the Planning Commission may help resolve the matter; she is not in favor of diagonal parking.

C/Tragarz stated that she is not in favor of diagonal parking on the property and supports a driveway on the right side, though she is not in favor of too wide of a driveway.

M/Pacheco and C/Ching recommended that the item be brought back to Planning Commission with professional plans.

M/Pacheco opened public comment. There being no further input, it was unanimously moved by Council to close public comment.
