DISCUSSION/REVIEW

- **City Operations with Anticipated Relief of State/County COVID Restrictions** – Staff has continued to monitor State and County discussions regarding the anticipated June 15 lifting of restrictions. In an effort to provide local governments adequate time to prepare for in-person public meetings, while remaining in compliance with the Brown Act, the Governor announced that the Executive Order providing local government agencies with the necessary flexibility to conduct business meetings in a virtual format would remain in effect after the June 15 reopening plan. Discussion includes public access to city facilities, public gatherings (i.e.: special events), and public meetings.
- **City position on Impacts of LA County District Attorney’s Office Criminal Justice Reforms and Special Directives** – The Los Angeles District Attorney has issued special directives and criminal justice reforms that may impact the City of Walnut. The purpose of the Study Session is to discuss those potential impacts and potential responses from the City Council.

ORAL COMMUNICATIONS

Under Government Code Section 54954.3, any person wishing to address any item or issue not on the agenda may do so under Oral Communications.

The Council may listen but may not act on items that are not already on the agenda.
