RECOMMENDATION:

It is recommended that the Parks and Recreation Commission receive and file the Parks and Maintenance Report for January 2022.

BACKGROUND:

This report is prepared and provided for the Parks and Recreation Commission for review and information on the current status of the maintenance and operations of the City of Walnut's Park system.

The Maintenance Division of the Community Services Department manages general park maintenance at all City parks. General maintenance is performed largely by a landscape maintenance contractor and some by the City staff. The general maintenance includes mowing, edging, hedging, pruning of shrubs and trees, as well as the monitoring of rodents and pests. It also includes irrigation audits and playground inspections. Restroom maintenance services are provided by the custodial contractor. Park restrooms are open and maintained seven days a week, with the exception of two holidays per year (Thanksgiving Day and Christmas Day).

City parks with sports fields are maintained at an optimum level through the services of sports field specialists. City staff augments the maintenance services through regular inspections and audits of the fields.

City maintenance staff also performs special projects in all parks including graffiti removal and playground equipment repairs. In order to conform to California playground standards, staff performs playground inspections on a weekly basis.

RECOMMENDATION:

Staff recommends that the Parks and Recreation Commission receive and file this report.

BACKGROUND:

This report is prepared and provided for the Parks and Recreation Commission for review and information on the Recreation Programs that occurred during the month of January.

SENIOR PROGRAMS:

The Los Angeles County Department of Public Health modified their Health Order to mandate indoor masking, regardless of vaccination status. Staff and program participants at the Senior Center and other City facilities are required to follow this mandate.

Following the winter holiday, Los Angeles County experienced a surge in COVID-19 cases. The Senior Center was impacted by a shortage of staffing. This lead to the facility being closed to the public from January 6 through January 30 and canceling all older adult programs including social groups and the Walnut Senior Citizens Club rental. The facility reopened on January 31. Excursions and leisure classes continued as scheduled during the closure. Staff continues to monitor the situation, with regard to the spread of COVID variants.

SENIOR CURBSIDE/HOME DELIVERED NUTRITION LUNCH PROGRAM

Staff continues to coordinate the County Nutrition Program for older adults, which had been a congregate meal program at the Walnut Senior Center. The program is now operated as a hybrid pick-up/home delivery programs. Those residents who cannot leave their home

continue to receive home delivered meals, while others are scheduled for drive-through (no contact) pick up. Los Angeles County has extended the curbside service to continue through 2022 until further notice.

MT. SAC OLDER ADULT CLASSES:

The winter session of classes was scheduled to begin on Monday, January 3 through late February. Due to the facility closure, classes resumed on Monday, January 31 and is set to conclude on February 18. The spring schedule is set to begin on Tuesday, February 22. Registration for classes was open online through January 30. Any late registration will be conducted on the first day of class with the instructor.

WEEKLY ACTIVITIES:

The Walnut Senior Center reopen their doors to the public welcoming back a few of the social groups including Mahjong, Bridge, Billiards and Tole Painting. All social groups have designated meeting times with the exception of Billiards, which is open Monday through Friday from 8:00 am to 5:00 pm. Masks are required of all participants and eating indoors (which would involve the removal of a mask) is not permitted at this time.

TEEN CENTER:

The Teen Center is open for the 2021-22 school year, regular hours are Monday through Friday from 2:00 pm to 7:00 pm and Thursdays from 12:30 to 7:00 pm for Suzanne's Early Out Days. Teens in 6th through 12th grade enjoy activities including sports, crafts, movies, board games and snacks. Teens also have access to various textbooks and computers to complete their schoolwork between the hours of 3:00 pm to 5:00 pm Monday through Thursday. On Fridays, the Teen Center hosts Film Fridays between the hours of 3:00 pm and 5:00 pm where teens are shown a movie on the projector screen. Parents have the option of purchasing the entire school year for \$100 or by semester for \$55 per semester.

Masks are required at all times and social distancing protocols area in place. The outdoor area in front of the Teen Center has been equipped with tables and chairs for teens who wish to eat a snack (eating inside is currently not permitted).

There are currently 285 registered members of the Walnut Teen Center.

Every Tuesday in the month of January the Teen Center hosted Special Treat Tuesdays where we sold milkshakes, fruity pebble treats and cupcakes and New Year's punch. The price ranging from \$0.50- \$1.00 each.

The Youth and Family Group Counseling program is conducted every Monday at 6:00 pm at the Walnut Senior Center. Masking and social distancing are required.

SPORTS LEAGUES & CLASSES:

Open Gym hours for Table Tennis, Badminton, and Basketball are available in the morning from 9:00 am to 1:00 pm at the Walnut Gymnasium. Limited-capacity, and all LACDPH protocols are being abided by.

Walnut Youth Basketball (WYB) League began games on December 18 as dates were pushed back due to Los Angeles County Health Department COVID-19 testing requirements for indoor youth sports. WYB is host to a total of 22 teams ranging from grades K through 8th. Practices are once a week for an hour and games on Saturday. WYB season will conclude in March.

Uptempo Basketball holds a number of classes including Little Dribblers, Skills Clinic, Advanced Dribbling Clinic and an Elite Clinic class. Classes range from beginner to experience skill set for children ranging in ages of 4 to 18 years of age.

The pickle ball, six month pilot program on Tuesdays and Thursdays debuted at Walnut Ranch Park on January 11. Staff has been monitoring the use of play, hosting community meet ups, and conducting clinics for anyone who wants to learn the game of pickle ball. There has been growing popularity from 4 people showing up to 28 people playing, most of whom, are Walnut residents.

SENIOR/COMMUNITY EXCURSIONS:

Spring registration for the 2022 season opens on February 14 for residents. Due to uncertainty created by the global pandemic, staff continuous to take a cautious approach to booking excursions. Capacity for trips has increased to 70% and continues to meet the busing company and venue guidelines. Masking is required on the bus and any indoor location (optional outdoors).

Winter 2022 excursions encountered a number of refund request due to a concern in the recent surge of Covid-19 cases after the holiday.

Registration for the spring 2022 schedule of classes opens on Monday, February 14 with Walnut resident priority. Classes are continue to take place with modifications and limited capacity. Classes are held indoors at the Walnut Senior Center or the Walnut Gymnasium.

SPECIAL EVENTS:

Lunar New Year Celebration

This year's celebration was postponed to Saturday, February 19, 2022 due to request from community partners in response to a surge in COVID-19 cases. Staff has been preparing a spectacular display in honor of the Year of the Tiger. This year Panda Express has graciously donated 800 fortune cookies, 300 activity books and 300 Cub Meal coupons and \$5 off family meal coupons for the community. The Walnut Valley Water District has sponsored the event at \$500 to help off-set cost for free milk tea with boba to be provided for free at the event.
