# **ORDINANCE:**

4. Ordinance No. 22-03 – Amending Title 4 – Licenses and Permits of the Walnut Municipal Code (WMC) to Establish a Tobacco Retail Licensing Program and Prohibiting the Sale of Favored Tobacco Products

**Recommendation:** That the City Council Introduce by title only and waive further reading of Ordinance No. 22-03, "An Ordinance of the City Council of the City of Walnut, County of Los Angeles, State of California, adding Chapter 4.06 to Title 4 – Licenses and Permits to the Walnut Municipal Code Establishing a Tobacco Retail Licensing Program and Prohibiting the Sale of Flavored Tobacco Products"; and agendize for adoption at the regularly scheduled City Council meeting of March 9, 2022.

MA/Ramos presented a staff report.

Discussion took place amongst Council and staff regarding enforcement of violations of the ordinance.

CA/Leibold clarified that any violation of the municipal code constitutes a misdemeanor unless it is specifically designated as an infraction and pursuit is up to the city attorney or city prosecutor, which would typically be pursued as a civil infraction.

M/Ching opened public comment.

Monty Messex provided information from the Los Angeles County Public Health office regarding the County's tobacco retail license.

Annie Tagen, Kelly, and Tim expressed support for the ordinance banning flavored tobacco products.

- 7. Determine that the Norm Ashley Park renovations are categorically exempt from the California Environmental Quality Act (Cal. Publ. Res. Code §§21000 et seq. "CEQA") and the State CEQA Guidelines (14. Cal. Code Regs §§15000 et seq.) pursuant to Section 15003 Class 3 Exemption in that the project consists the renovation of an existing playground and basketball court in an existing park involving negligible or no expansion of use, and direct staff to file a Notice of Exemption (NOE) with the Los Angeles County Clerk.

CSS/Barcelo provided a staff report.

C/Tragarz stated that she would like to place an item on a future agenda to change the name of the park to Bert and Norm Ashley Park and proposed adjourning the meeting this evening in memory of Bert Ashley.

C/Pacheco provided information on the history of the park.
