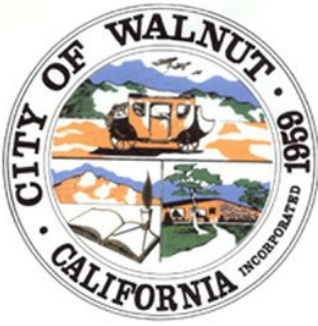

SUBJECT: SENIOR CENTER ACTIVITIES FOR APRIL 2022

### SUMMARY:

The Senior Center staff has prepared a report summarizing the activities at the Walnut Senior Center during the past month.

### **COVID-19 Protocols Update:**

The Los Angeles County Department of Public Health modified their Health Order to highly recommend indoor masking, regardless of vaccination status. Staff and program participants at the Senior Center and other City facilities have been updated of this modification.

### **ACTIVITIES SUMMARY:**

The following are ongoing social services for older adults in Walnut that occurred last month. Staff continues to provide older adults in the community with pressing social services opportunities.

### **SENIOR CURBSIDE/HOME DELIVERED NUTRITION LUNCH PROGRAM**

Staff continues to coordinate the County Nutrition Program for older adults, which had been a congregate meal program at the Walnut Senior Center. The program continues to operate as a hybrid pick-up/home delivery programs. Those residents who cannot leave their home continue to receive home delivered meals, while others are scheduled for drive-through (no contact) pick up. Los Angeles County has extended the curbside service to continue through May 2022.

MT. SAC OLDER ADULT CLASSES:

The spring session of classes began on Tuesday, February 22. We are happy to share that all classes are taking place with maximum attendance for each of the courses being offered.

GROW GROUP COUNSELING

The Senior Group GROW Group Counseling program has continued to be in person, since the transition of the virtual forum. GROW meets the first Friday of every month from 9:00 am to 11:00 am. Participants ages 55 and older are welcome and encouraged to learn new skills that will allow them to GROW.

SENIOR EXCURSIONS:

Registration for the spring trips began on February 14 for Walnut residents. All trips for the spring are currently approaching full capacity with only couple of spots left for each trip. Capacity for trips is reduced to half in order to maintain distancing. Here are the February excursions:

WEEKLY ACTIVITIES:

The Walnut Senior Center will reopen their doors to the public welcoming back a few of the social groups including Mahjong, Bridge, Billiards and Tole Painting. All social groups have designated meeting times with the exception of Billiards, which is open Monday through Friday from 8:00 am to 5:00 pm. Masks are required of all participants and eating indoors (which would involve the removal of a mask) is not permitted at this time.
