RECOMMENDATION:

It is recommended that the Parks and Recreation Commission receive and file the Parks and Maintenance Report for June 2022.

BACKGROUND:

This report is prepared and provided for the Parks and Recreation Commission for review and information on the current status of the maintenance and operations of the City of Walnut's Park system.

The Maintenance Division of the Community Services Department manages general park maintenance at all City parks. General maintenance is performed largely by a landscape maintenance contractor and some by the City staff. The general maintenance includes mowing, edging, hedging, pruning of shrubs and trees, as well as the monitoring of rodents and pests. It also includes irrigation audits and playground inspections. Restroom maintenance services are provided by the custodial contractor. Park restrooms are open and maintained seven days a week, with the exception of two holidays per year (Thanksgiving Day and Christmas Day).

City parks with sports fields are maintained at an optimum level through the services of sports field specialists. City staff augments the maintenance services through regular inspections and audits of the fields.

City maintenance staff also performs special projects in all parks including graffiti removal and playground equipment repairs. In order to conform to California playground standards, staff performs playground inspections on a weekly basis.

BACKGROUND:

This report is prepared and provided for the Parks and Recreation Commission for review and information on the Recreation Programs that occurred during the month of June.

SENIOR PROGRAMS:

SENIOR CURBSIDE/HOME DELIVERED NUTRITION LUNCH PROGRAM

Staff continues to coordinate the County Nutrition Program for older adults, which had been a congregate meal program at the Walnut Senior Center. The program continues to operate as a hybrid pick-up/home delivery programs. Those residents who cannot leave their home continue to receive home delivered meals, while others are scheduled for drive-through (no contact) pick up. Los Angeles County has extended the curbside service to continue until further notice.

SENIOR DINE-IN NUTRITION LUNCH PROGRAM

As of June 20, Los Angeles County has reinstated the Senior Dine-In Nutrition Lunch program. The Dine-In program is open to older adults aged 60 years and older. Currently we are serving hot meals Monday through Wednesday on a first-come first-serve basis. To participate, guest must complete an intake form, check-in opens at 10:30 am with meals served from 11:00 am to 12:00 pm or until food is available.

SPECIAL EVENTS:

Luau Dinner and Dance

On Friday, June 24, the Senior Center held a Hawaiian Luau Dinner & Dance. The event featured the band, Global Affair, an authentic Hawaiian show by Da Hula Studio and prizes. A Hawaiian themed meal was catered by Da Kine Hawaiian Grindz Catering. The attendance for this dance was sold out at 120 guests. Participants enjoyed the evening festivities and all were given a special mahalo for attending. Oakmont Senior Living was our event partner with a contribution of \$500.

OLDER ADULT CLASSES:

Heart and Soul Line Dance classes have been in full swing offering lessons twice a week. Monday classes are perfect for the working older adult and scheduled for 6pm. Thursday classes are perfect for the retired person, scheduled for the morning at 9:30 am. These classes are a perfect way to good heart health without the constant strain on joints and easy to follow. All levels are welcome and no partners necessary.

Registration for the summer session of classes began on May 1 and continued through the month of May with online registration. Participants unable to register online or needing assistance are able to contact Mt. SAC directly or visit on any schedule date to speak with someone in person. Classes began the week of June 20.

TEEN CENTER:

The Teen Center Summer hours are now open starting June 6 to August 5. Fees are \$75 per teen. Teen Center summer hours will be Monday through Thursday from 12:30 pm to 6:00 pm. Teens in 6th through 12th grades enjoy activities including sports, crafts, board games, movies, air hockey, table tennis, foosball and pool.

The Youth and Family Group Counseling program is conducted every Monday at 6:00 pm at the Walnut Senior Center.

SPORTS LEAGUES & CLASSES:

Open Gym hours for Table Tennis, Badminton, and Basketball are available in the morning from 9:00 am to 1:00 pm at the Walnut Gymnasium and volleyball on Tuesdays from 6:00 pm to 8:30 pm.

Uptempo Basketball Academy held one of their three camps in June. The camp was held June 13 – June 16 from 9:00 am to 2:00 pm. This four day camp hosted 59 participants that were engaged in multiple skill learning drills and scrimmage games on a daily basis. Uptempo will hold two more camps; one in July and one in August.

Walnut Youth Basketball (WYB) summer season registration began games on June 18th. Each team practices once a week for an hour. The summer season will conclude on July 30th. WYB season is for children in grades K thru 8th, it is a co-ed league.

The extended pickleball pilot program from May 30- September 2, 2022, allows for pickleball play seven days a week. Staff has been seeing more consistency on the weekends with community members learning and playing pick-up games of pickleball.

SUMMER CAMPS AND AQUATICS:

Camp Crawdad

Camp Crawdad is back this summer hosting two, four-week sessions. A nominal registration fee of \$100 per resident participant and \$110 for non-resident is required to assist with the cost of the program. The registration fee covers a camp T-shirt, water bottle and one session (four weeks) of fun activities. Camp Crawdad meets Monday through Thursday from 9:00 am to 11:30 am at Lemon Creek Park. Registration is ongoing. The first session of Camp Crawdad began on Monday, June 6 and had a total of 80 registered participants, designed for participants to be grouped into pods.

Each registered participant received a Parent Handbook upon registering. This is to encourage the parents and campers to read together and learn about the camp and what it has to offer. Included in the Parent Handbook is a calendar that shows the different themed weeks of Camp Crawdad. Staff has themed all eight weeks and has structured activities specifically around each theme. Overall, participants experience a fun mix of activities each day, some of which include morning workouts, sports, games, and arts and crafts.

Camp Movin' n' Groovin (CMG) is back this summer to host ten weeks of fun programming. This camp is appropriate for youth ages 7 to 14 years. It includes an assortment of activities designed to get children "moving" as well as crafts, trips and snacks. In the month of June CMG was completely sold out with 40 campers each week. Campers enjoyed themed weeks called Summer Vibes, Soakin' Fun, Myth Busters, To Infinity & Beyond, and Out n' About. Field Trip days are on Wednesday of each week and included trips to Knott's Berry Farm, Corona Del Mar Beach, Pacific Park, El Capitan Theater, and John's Incredible Pizza.

The Walnut Valley Unified School District allocated time at the Walnut High School pool this summer. While this time is truncated from prior years, it most importantly permits the City to offer Tiny Tots, all swim levels (1-5), private lessons and adult lap swim. Current staffing levels also work well with the allotted time. Group and private swim classes began May 31 as well with classes starting at 9:30 am and running approximately 30 minutes throughout the day. The Aquatics program will run for 10 weeks and will also have lap swim for adults.

The Recreation Division Sharks Swim Team for the summer began practices May 31 practices are held Monday through Friday from 7:15 am to 9:15 am. The Sharks Swim coaches are

working on scheduling meets with surrounding cities like La Verne, San Dimas and Duarte prior to the SCMAF San Gabriel Association meet that will be held July 23.

SENIOR/COMMUNITY EXCURSIONS:

Excursions are in full swing all while staff continuous to take a cautious approach to booking excursions. Capacity for trips is currently at 70% and will increase to 100% in June. Masking is no longer being required on the bus, however most venues still require mask and vaccinations.

Recreation classes are introduced two new programs this summer. The Hip Hop Dancers and Hollywood Superstars offered though Talented Arts have been well received with a total of 39 students participating in the classes.

RECOMMENDATION:

Staff recommends that the Commission advise the City Council to:

- 1. Extend the seven day a week pilot program through December 30, 2022.
- 2. Explore the feasibility and develop cost estimates to either (a) convert Court A for pickleball play or (b) add pickleball courts to the park property located immediately east of Court C (photo attached).

BACKGROUND:

On May 25, 2022, City Council approved an expansion of the two day a week pilot program by allowing Tennis Court A at Walnut Ranch Park to host pickleball seven days a week, from May 30- September 2, 2022. The original program was approved by Council on December 8, 2021, allowing Tennis Court A to be dual striped for tennis and pickleball use on Tuesdays and Thursdays. The six-month pilot program began on January 11, 2022.

In order to mitigate the impacts of using Court A and to provide more tennis courts for recreational use, staff secured Courts 4, 5, and 6 at Walnut High School to be open for free public play Monday through Friday from 3PM-9PM and Saturday and Sunday from 9AM-6PM. This free use will continue as long as WVUSD approves our facility use application.

ANALYSIS:

Despite the summer heat wave, Walnut pickleball play has been steadily growing, largely in the evening hours as shown in the attached Table.

Staff has been able to monitor the tennis and pickleball usage at both Walnut Ranch Park and Walnut High School and has observed that both locations and sports are being heavily utilized in the evening.

The pilot program establishes that Walnut residents are still interested in playing pickleball. Expanding the program to include play opportunities in the cooler months while exploring options to add permanent courts will give the Commission and Council more time to determine the viability of investing modest or considerable capital funds to create a more permanent place for the sport and will support continued pickleball play.
