Richard Macis expressed concerns regarding the increase of gophers in his neighborhood due to adjacent construction.

3. The Terraces at Walnut – A request to amend the adopted "The Terraces at Walnut SP", Development Agreement (DA) and Tentative Tract Map (TTM) 78210 to allow for an Entry Gate (SPC/AR 2022 – 086) into the Small-Lot and Single-Family District(s), located at the northerly end of the Project site

Recommendation:

- 1. Open the Public Hearing;
- 2. Hear the Staff Report;
- 3. Receive testimony from the Applicant and any other members of the Public regarding the Project;
- 4. Discuss amongst Council Members;
- 5. Close the Public Hearing;
- 6. Take One (1) of the Following Actions:
 - a) Approve the following:
 - i. Ordinance No. 22 08: Approving the Amendment to the DA, in substantial form (Exhibit A).
 - ii. Resolution No. 22 52: Approving Amendment 1 to the "Terraces at Walnut" Specific Plan, Amendment 1 to TTM 78210, and SPC/AR 2022 086, subject to the attached Conditions of Approval (COA) in Exhibit B.
 - b) Deny the request.

M/Wu opened the public hearing.

CDD/Vasquez presented a staff report.

Bob Russi, the applicant representative, provided information on the proposed entry gate as well as an update on the project.

Discussion took place amongst Council and staff regarding the proposed entry gate.

M/Wu opened public comment.

Teresa De Dios read into the record emails from Janelle Law, Martin and Eileen Robles, Wendy Toy, Vijay Vakil, Charles Issac, William Harrison, Matthew Zanka and 34 other residents opposing the proposed gate.

Robert Anderson, Eric Wang, Larry Lin, Daniel Dang, Sophie Su, Simon Su, Lily Chen, Rowland Heights resident, Diamond Bar resident, Rainbow, Shirley, Grace Wong, Larry Waldie, Jim Dixon Jr., Sophia Liu, Joseph Tang, Dr. Henry Sang, and Annie Wong asked that Council approve the proposed entry gate.

Kevin Bush expressed concerns regarding the gate and asked Council to deny the gate.

Nadia Anderson expressed safety concerns in her neighborhood.

William Harrison stated that he is in favor of gates, but that every other community should have the right to a gate.

Vijay Vakil expressed concerns regarding The Terraces development and asked Council to deny the gate.

Discussion took place amongst Council and staff regarding the proposed entry gate, public safety concerns, previous gated community requests, the wording of the ordinance, the City's general plan and specific plan process and the parks in the development.

MPT Tragarz stated that she is against approval of the gate.

C/Freedman expressed concerns approving the gate including access for residents to the gated community and also language in finding d(2) of the ordinance and recital H of the development agreement. She would like Sunjoint to consider other possibilities to increase safety in the development.

CA/Leibold recommend that finding "d(2)" on the ordinance be revised to state: "The Terraces at Walnut project is a residential and commercial project that incorporates parks and open spaces throughout the development. The project incorporates walkability and connectivity opportunities and will establish a new integrated community in Walnut. The proposed amendment authorizing gates and a guardhouse at the sign family neighborhood, promotes property values of the site and properties in the vicinity of the project and is not materially detrimental to the use and enjoyment of properties in the vicinity." She stated that the alternate language of "d(2)" eliminates the statement that the parks are public though the developer has provided confirmation that the parks will be available via pedestrian access to residents of the city. She clarified regarding recital H of the development agreement, which considers if the proposed amendment is consistent with the general plan and the Terraces specific plan. She stated that Council can revise recital H to state that Council conducted a public hearing introducing the ordinance.

MPT/Tragarz and C/Freedman stated that they would like recital H revised.
