NOTICE OF VIOLATION

Your property located at <u>one lot west of 20201 Alta Hacienda Drive, Walnut</u> was inspected on <u>August 12, 2022</u> and found to contain combustible grass, weeds, and/or brush in violation of the County of Los Angeles Fire Code.

In order to bring your property into compliance with the Fire Code and avoid possible legal action, you must perform the following checked item(s) by **September 4, 2022**.

- X 1. Clear, cut back, thin out, trim up and remove flammable vegetation or combustible growth for a distance of 200 feet from any structure (even if the structure is not on your property) so as to create a firebreak. This section shall not apply to single specimens of either native or ornamental trees, shrubs or ground covers provided they are cut back, thinned out, trimmed up and spaced so as to provide an adequate firebreak and do not form a fuel ladder to any structure. (F.C. 325.2.1(2), 325.2.2)
 - 2. Roadways: Clear and remove all flammable or combustible growth for a minimum of 10 feet on each side of every roadway whether public or private. (F.C. 325.10)
- X 3. Other: Clear weeds and trim up trees and bushes 6 feet off the ground within 200 feet from structures.
