5. Multi-Way Stop Warrant Results – Francesca Senior Housing

M/Wu opened public comment.

Mr. Lee, lives at the senior housing complex, he challenged the Traffic Safety Committee on their recommendation; he believes there should be a stop sign install to prevent accidents.

William Harrison confirmed there is speeding at location in question and requested for a stop sign to be placed.

Jimmy, mentioned there is also a Kindergarten school near the location and suggested a Stop sign.

Vijay Vakil questioned why the City does not want to place a stop sign.

CE/Gilbertson explained that stop signs are not used for slowing traffic. He explained his reasoning and data to backup the committee's decision, the City's liability, and state and county road standards.

There was discussion amongst the City Council and staff.

Mr. Lee expressed he felt he was being discriminated against and argued why there could not be a stop sign placed at the location and asked what the City can do to help the residents in that community.

CA/Leibold said these are State mandated guidelines; they are uniform policies and State mandates that have to be followed.

MPT/Tragarz reiterated the City Attorney's comments. She explained there were already speed bumps in place.

William Harrison commented that the 2024 election was coming up and to remember who the residents were voting for.

CE/Gilbertson provided information on speed bumps installed and the guidelines followed by the City.

M/Wu asked if they had been evaluated, to which CE/Gilbertson responded yes.

C/Cajulis asked CE/Gilbertson if they will be reassessed in the future to which CE/Gilbertson responded yes.

MPT/Tragarz added that the speed was posted.
