2. Introduce by title only Ordinance No. 23-02, waive further reading and set for adoption on June 28, 2023, "An Ordinance of the City Council of the City of Walnut, California, Adding Chapter 3.68 (Trespass on Designated Conservation Areas) and Chapter 3.72 (Trespass on City Property) to Title 3 (Public Health, Safety and Welfare) of the Walnut Municipal Code".

CA/Leibold provided a staff report and reported the urgency ordinance will take effect immediately if adopted. The second ordinance will be introduced and brought back at a future meeting for second reading and adoption and will take effect 30 days thereafter.

C/Ching inquired if there are arresting powers with this ordinance.

CA/Leibold explained this would be treated as a misdemeanor and law enforcement may issue a citation.

## 7. Approval of Traffic Safety Measures on Francesca Drive

**Recommendation:** That the City Council approve the following traffic safety measures on Francesca Drive:

- a. Extending the red curb by 75', increasing the restricted parking area on the east-side of the driveway;
- b. Removal of the entryway hedge on the east-side of the driveway to be coordinated with the Senior Housing HOA; and
- c. Installation of two (2) W-70 "Cross Traffic Ahead" warning signs, one (1) eastbound and one (1) westbound

CE/Gilbertson provided a staff report and addressed some of the concerns that were raised earlier by a resident from Francesca.

There was discussion amongst Council and staff about visibility, liability against city, signs and flashing signs, and making the area a safe place for the residents.

CA/Leibold explained that the City complies with the uniform standards.

Sheriff representative explained that if the City decides to add a stop sign at the location in question, it will not be enforceable.

M/Wu asked staff and City Engineer to review the visibility issue at the location. CE/Gilbertson agreed to meet with M/Wu.

Discussion continued amongst the City Council regarding item 7

CSD/Barcelo explained that staff received feedback from residents in the area that it would be a far distance to walk.

CM/Weiner requested clarification if the motion was to approve additional language.

C/Ching explained that the motion was to adopt staff's recommendation as proposed.
