# 2. Five (5) Lot Residential Subdivision on Camino De Teodoro

- 1. **Tentative Parcel Map (TTM) 83611**: A subdivision of approximately 83,984 square-feet (1.92-acres) of land into five (5), single-family residential lots located along Camino De Teodoro (APNs: 8722-019-025, -028, -029, -033).
- 2. Site Plan Case/Architectural Review (SPC/AR) 2022-043: A proposal to construct five (5) new, single-family residential units ranging in size from 4,449 square-feet to 4,490 square-feet, respectively.
- **3. # 12. Economic Development (Special Event): Taste of Walnut

**Recommendation:** That the City Council:

- 1. Approve Walnut Valley Educational Foundation (WVEF) as being the event local non-profit for the Taste of Walnut (TOW) event;
- 2. Approve the beer and wine garden at and during the TOW as outlined in Ordinance No. 22-05;
- 3. Authorize the appropriation of \$60,000 (not to exceed) from the collected Development Agreement Fund(s) (24-2200).

DCSD/Bumia presented a staff report. The event is proposed to be held on Saturday, March 23, 2024 from 4 to 8 p.m. at Suzanne Park with food booths, beer and wine garden, and security to make sure alcohol is kept in the designated area.

M/Tragarz inquired how much funding is anticipated from sponsorship.

DCSD/Bumia responded staff has not reach out yet, but staff expects that whatever is received the City will offset the cost.

Discussion took place amongst Council and staff regarding the number of tickets for sale and what's included in the ticket cost, ownership of the event, and vendor stipends provided by the Walnut Valley Educational Foundation.

MPT/Freedman said there was positive feedback from last years event and the local businesses were promoted.

M/Tragarz expressed concerns regarding the city's liability for the event.

DCSD/Bumia explained that the WVEF will take responsibility for the alcohol portion of the event.

M/Tragarz invited the public to speak on this item.

Mr. Harrison expressed his concerns relating to the event and the liabilities involved.

# 13. Update on the Establishment of a Sewer Reimbursement District for the Castlehill Drive and Slope Drive Neighborhood

**Recommendation:** That the City Council abandon the establishment of a Sewer Reimbursement District for the Castlehill Drive and Slope Drive neighborhood because only 35% of the impacted property owners responded in favor of the project.

#### Alternative:

Authorize City staff to proceed with the reduced scope project that includes the properties on Slope Drive and the southerly portion of Castlehill Drive (21 properties) at a reduced total construction cost of \$1,150,000 and an increased reimbursement cost per parcel of \$55,000.

CE/Gilbertson provided a staff report. He reported staff had sent letters to the residents residing in the area mentioned and also walked door to door to provide information.

There was discussion amongst the City Council and staff on the responses received by the City Engineer from each of the property owners affected.
