CA/Leibold stated that comments for the EIR for the physical education project at Mt. SAC are due on July 3rd.

Discussion took place regarding the project and issues presented as well as the contract for the consulting, and the scope of the work that needs to be done in related to the project.

C/Tragarz expressed concerns in regards to spending \$30,000 on the physical education project, having the contract already signed, and the cost per hour of the consultants. She would like to discuss the issues with the full Council.

CM/Wishner stated that Community Development is asking for help due to technical aspects to the work.

C/Tragarz inquired into the total costs relating to Mt. SAC litigation; to which ASD/Ogawa stated that is approximately \$155,000.

M/Ching inquired into the impacts if the item is tabled until the June 28th meeting; to which CDD/Weiner stated that staff would have to formulate the response for the EIR without the help of the consultant.

CM/Wishner shared that C/Tragarz concerns are warranted in regards to cost, but staff will always ask for assistance if they feel it is necessary.

CA/Leibold stated that staff has only begun to review the documents produced by the school and shared the issues that she feels merit review.

Council opened up the item for discussion.

Hassan Sassi spoke in support of contracting a consultant to review the document.
